RENEWAL OF MEMORANDUM OF UNDERSTANDING

SIGNED DATED 14.02.2015

This Memorandum of Understanding signed on 24<sup>th</sup> April, 2022, by and between **Bhairab Ganguly College** having its registered office at 2, Feeder Road, Belghoria, Kolkata – 700 056, represented by the Principal of the college, (Prof.) Dr. Subhranil Som, hereinafter referred to as the “College Authority”

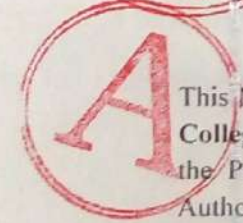
AND

**DATA-Q**, an Institute accredited by **NIELIT** having its registered office at Barasat Govt. College, K.N.C road, Kolkata- 700 124, represented by the Director, Mr. Pinaki Rudra, hereinafter referred to as the “Centre Authority” (an expression which shall mean and include its successors in office administration, authorized representatives and assignees). The “College Authority” and the “Centre Authority” shall be collectively referred to as Parties.

Now, therefore, this Agreement witnesses that the “College Authority” and the “Centre Authority” have unanimously agreed to continue IT education under National Institute of Electronics & Information Technology, formerly DOEACC SOCIETY, Department of Electronics & Information Technology, Govt. of India & AICTE for the existing college students ex-students as well as outsiders.

For conducting the NIELIT course both the Parties have mutually agreed upon the terms and conditions mentioned herein below:

IN THIS MOU, UNLESS the context otherwise requires :-

(a) Royalty means, the amount ( 20% of the total monthly collection towards monthly instalment ) agreed between the Parties herein to be paid after six months from the date of reopening of the Computer Centre by the "Centre Authority" on a quarterly or half-yearly basis for the facilities provided by the "College Authority" to setup, run and maintain the Computer Centre at the college premises.

(b) Total monthly collection, means the monthly instalment amount realized from the students of the Computer Centre, be it a student of the college or outsider, except the collection on account of Admission fee, NIELIT registration Fee, Examination Fee and Library Caution Deposit.

(c) Student means, one undergoing training and education in the Computer Centre of Bhairab Ganguly College.

(d) During the tenure of the MOU or any extension period, thereof, the "College Authority" shall not allow any other organization or individual to run such Computer Centre within the college premises.

It is also hereby acknowledged that after the completion of the Computer course, the students will receive Course Completion certificates, duly signed by the signatories of both the "College Authority" and the "Centre Authority". The certificates will contain the logos of both the Parties.

MEMORANDUM OF UNDERSTANDING

  - ( c ) The " Centre authority" will arrange the minimum requirements for conducting computer course such as white board , White Screen , PC, Broadband Internet Connection, course related software ( licensed ) . / open source

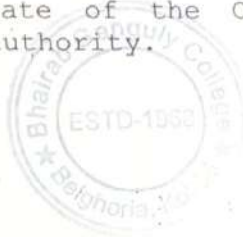
