Abstract:

All text including ‘Abstract’ should be in Times New Roman font, font size 10 and right and left justified. Abstract should be within 100 words. Abbreviations/ acronyms, mathematical equations or references should be avoided in the abstract. Readers should be able to have an overview of the work from the abstract.

Introduction:

This section should include a brief review of the existing literature in the topic of the manuscript and place the research work in its proper perspective. A brief statement on the obtained results should preferably be included.

Manuscripts should be submitted in Word 2007 or higher version. Use normal, plain font (e.g., 10-point Times Roman) for text and italics for emphasis. Use equation editor or MathType for equations, table function (not spreadsheets) for tables and ‘tab’ (not spacebar) for indents. Headings should be in 12 font and in Bold. Subheadings if any, should be in 11 font, Bold. *Page format should be A4 with 1 inch border on all sides and the extended abstract should not exceed two pages.* Reference numbers [X] should be within third brackets. Abbreviations should be defined at first mention and used consistently thereafter.

Other Sections:

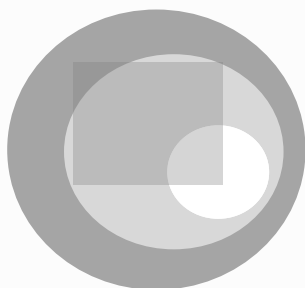


Fig.1 Experimental results with

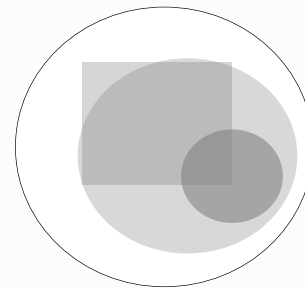


Fig.2 Experimental results with

Other sections, for example (e.g), Theory, Results, conclusion, References [1-7] should follow the same pattern. Figures should not overflow beyond the margins. Figs. and figure captions are illustrated in Figs. 1 and 2.
